## RFMD's LodeStar 3G RF Solution To Feature DigRF3G Digital Interface

DigRF3G is an industry standard digital interface between the cellular transceiver and the cellular baseband that improves time-to-market, lowers cost, reduces size and eases system integration in next-generation 3G multimode, multi-band handsets. RFMD is a founding member of the original DigRF working group and is proud to play a leading role in the development of the DigRF3G specification and beyond. Leveraging deep systems-level expertise, RFMD is a proven leader in the development and implementation of digital radio interfaces, having shipped more than 100 million devices based on a digital interface since the introduction of POLARIS® 1 in 2004. RFMD's LodeStar 3G RF Solution will feature a fully compliant DigRF3G digital interface.

"This announcement is an important milestone as it demonstrates in hardware the promises of the DigRF3G specification, namely a pin efficient, low-power, high-performance interface between the RF system and the baseband," said Navi Miglani, RFMD strategic marketing manager and chair of the MIPI DigRF working group. "In 3G multi-mode handsets, the implementation of the DigRF3G standard provides handset manufacturers a standardized radio interface, paving the way for the adoption of 3G across all tiers of mobile handsets. By utilizing DigRF3G compliant solutions, tier one handset manufacturers can cost-effectively develop highly versatile reference platforms that optimally match RF systems to basebands. These platforms can then be quickly ported to multiple handset configurations in order to address the specific needs of a particular mobile operator's handset tiering strategy."
